All information collected is kept in strict confidence and is only used internally for management of Events Edmonton.

THIS CONTRACT made and entered into between Events Edmonton, hereinafter referred to as the Association and hereinafter referred to as the Renter, for the express purpose of renting the Showmobile.

**A. PURPOSE OF EVENT:**

1. Events Edmonton reserves the right to refuse rental of the Showmobile for any event deemed a potential hazard to the Showmobile or its operators or any event deemed not in the best interest of the Events Edmonton or the general public.
  
2. The rental or group requesting use of the Showmobile shall have the representative present at the site at the time the unit is scheduled to arrive. This representative is to direct placement of the unit and to accept delivery on any equipment rented by the user for the activity involved.

**B. FEES:**

In consideration for rental of this Showmobile, Renter shall pay to the Association:

Daily rental rate                   \$650.00

Additional day rental rate       \$500.00

Delivery & Pickup charge       \$500.00

Out of town must add \$2.00 per kilometer, both ways to the delivery and pickup charges

All deliveries and pickups will be done by Auto Rescue.

**Deposit of 50% must be paid before Showmobile is delivered**

C. Association invoice will be sent immediately following the event. **Payment shall be due within thirty (30) days.**

D. **INSURANCE:** Renter must provide a Certificate of Liability Insurance evidencing coverage in the minimum amount of \$2,000,000 combined single limit liability insurance naming Events Edmonton as **Additional Insured.**

E. **RENTER** agrees to indemnify and forever hold harmless the EVENTS EDMONTON, ITS OFFICIALS AND EMPLOYEES, from and against any and all claims, suits, actions, damages and/or causes of action, brought by any person, corporation, or other entity, arising out of the possession and use of said property, during the term of this lease, for any personal injury, loss of life and/or property damage, and from and against all costs, expenses and liability incurred, or order or judgment entered, as a result of any such claim, the investigation thereof or the defense of any action, including attorney's fees.

F. **RENTER** shall abide by all rules and guidelines for the Showmobile as stated above.
